All shooting is on paper targets only and must be hung in such a way so that the spent round(s) will impact the bank behind the range. Also, target supports are not targets! We have to police ourselves to ensure the longevity of our range. What you bring in – bring out. Pick up your ammo, targets and any cardboard and discard appropriately.

We have range officers with vests who will be monitoring the range daily. Remember no card, means no shooting. One guest, one time – no exceptions. You do not have to be a range officer to ask someone to show their card. Please be safe and have fun.

President's Message – Jim Nishan

I alerted the shooting chairpersons at the April meeting that I'd like to see a competitive club championship event in late August or early September. I'd like to see archery events, trap, rifle and pistol event to include muzzle loader. Details will be coming but I am looking to this as a fund raising event to help improve facilities for all members.

There have been a number of incidents reported from the pistol and rifle range of individuals loading and shooting on a cold range, shooting at items on the ground (causing ricochets) and more. The range chairman has purchased vests for his range officers and they will be checking. I will also be checking once or twice a day when I hear shooting. If you see unsafe acts please report them at the Lounge if no range officers are present. The bartender will call me and if I am in the area I will respond. Taking plate numbers could help identify those causing the problem.

The following may be of interest. The House has stood up for us, now it is up to the Senate. Stand up for your traditional sporting rights and call your senators.

NEWTOWN, Conn. -- The National Shooting Sports Foundation (NSSF), the trade association for the firearms, ammunition, hunting and shooting sports industry, hailed today's passage of the Sportsmen's Heritage Act of 2012 (H.R. 4089). The bill passed the House with a 274-146 vote. Sponsored by Rep. Jeff Miller (R-Fla.), the bill combines four legislative priorities that will expand recreational hunting, shooting and fishing opportunities and also reaffirms existing law and heads off determined bureaucratic efforts to deny hunters and shooters from using traditional ammunition. This important legislation is supported by more than 35 national conservation and sportsmen's groups. "NSSF thanks Rep. Miller for his exceptional leadership in helping to expand access and opportunities for sportsmen and in protecting and preserving America's hunting and shooting heritage," said Lawrence G. Keane, NSSF senior vice president and general counsel. "We look forward to seeking passage of the bill in the Senate." Said Rep. Miller, "I think it is important to recognize the contributions that sportsmen make to protect our nation's most precious resources. Outdoor activities like hunting and fishing are a central part of our heritage and way of life, but they also help fund a good portion of our conservation efforts. We must remain ever diligent to ensure the rights of sportsmen. Thanks to the members of the sportsmen's community, Congressional Sportsmen's Caucus and the House Committee on Natural Resources, H.R. 4089 will be able to address some of the most pressing concerns the outdoors community faces."

Included in H.R. 4089 is the Hunting, Fishing, and Recreational Shooting Protection Act. The bill amends the Toxic Substances Control Act to clarify the original intent of Congress to exclude traditional ammunition -- ammunition containing lead-core components -- and fishing tackle from regulation by the Environmental Protection Agency.

H.R. 4089 includes other key legislative priorities of the sportsmen's community:

- The Recreational Fishing and Hunting Heritage Opportunities Act, which requires federal land managers to support and facilitate use and access for hunting, fishing and recreational shooting.
- The Recreational Shooting Protection Act, which requires National Monument land to be open to access and use for recreational shooting.
- The Polar Bear Conservation and Fairness Act, which will allow the importation of polar bear parts taken in a hunt in Canada, if legally harvested before certain dates.

Worcester County League – Craig Cortis

The April League meeting was held 4/20/12 at Leicester Rod and Gun. We were told that the club has about 300 acres in total, an impressive amount for one club. Bill Davis of MassWildlife reported that the Merrill Ponds W.M.A. (Wildlife Mgmt. Area) in Sutton, a former warm water fish hatchery, actually has 7 dams within its borders. The Office of Fishing and Boating Access (O.F.B.A.) is drafting reports on these dams while Bill's Central District (Worc. County) evaluates the habitat value and recreational use of the various impoundments. Two of the ponds within the W.M.A. no longer hold water; two others are used regularly for fishing, canoeing and kayaking. The whole network of ponds ultimately flows into Lake Singletary. Bill Davis also mentioned that several destructive wildfires have recently been set by one or more arsonists on some W.M.A.s in Petersham, Phillipston, Millbury and other areas not fully tabulated. Various investigations are underway, of course. Alert citizens who might witness suspicious activity along these lines would certainly do us all a favor by reporting information to authorities forthwith. I gave a report at the April meeting of Quabbin Watershed Advisory Committee, a board on which I serve as a delegate representing the Worc. County League. Delegates at that meeting were treated to an extensive presentation on moose biology and feeding habits, narrated by a specialist who conducts such research in conjunction with UMass, Amherst. We were told that an adult moose (particularly bulls) can routinely consume from 50 to 60 pounds of browse daily during the approx. 6-month spring-through-fall growth period of highest vegetation availability. Ron Amidon of Otter River Sportsmen's has been in touch with certain members of land trust and trail organizations that have shown an interest in joining W.C.L. – our shared concerns in preserving undeveloped, open land have brought this about.
